The 236th regular meeting of the Board for Volunteer Firefighters and Reserve Officers was convened at 9:00 A.M. in Suite #207 in the James R. Larson Forum Building by Chair Martin Spani, with Board Member Miland Walling, Board Member Debora Smith, Board Member Brian VanCamp, Board Member Phin Haglin via zoom, and Executive Secretary Hailey Blankenship present.

There were no corrections to the agenda.

The Board reviewed the April 25th Board Meeting Minutes. No Corrections were noted.

### **OLD BUSINESS**

Secretary Blankenship updated the Board on the progress of the benefit enhancement project. Secretary Blankenship worked with contracted legal services, the AAG's office and other state agency representatives to draft bill language that will request the administrative changes needed to bring the Volunteer Firefighters and Reserve Officers pension plan into compliance with Federal Tax Laws. The plan as it is, must be split into two separate plans; one for fire and EMS service personnel and the other for reserve law enforcement officers. The draft language will be sent in for early submittal in September. Secretary Blankenship will get support from WFCA to find bill sponsors and reach out to WASPC to gain their support in the effort was well.

Secretary Blankenship updated the Board on the database replacement project. Linea Solutions has hit the ground running to outline the detailed business needs to procure the solution vendor. Independent Quality Assurance has been brought onboard. Stellar Associates was re-contracted for QA services after being on the project during the last phase. The Linea team will work with Secretary Blankenship and the project oversight team to procure the solution vendor that is expected to be early this summer with implementation to follow. The procured product will be a modern web based solution that provides ongoing updates as well as real time access to stakeholders in addition to the current methods of reporting and contacting staff with questions. Linea will join the October board meeting to give a project overview to the Board.

Secretary Blankenship updated the board on the LODD Benefit under review for Alan Basso. The results from Mr. Basso's Independent Medical Review were received back and it was said that his passing was not a result of his volunteer fire service duties. The IME results were shared with Mrs. Basso and her legal representation. We are waiting for a response on whether or not they wish to proceed with an appeal. If they do, we will have to set a hearing date.

Secretary Blankenship presented the Board with a hand out from the Office of the State Actuary. The purpose of the handout is to present the Board with a preliminary outline of the 2021 annual valuation. The BVFF staff was unable to pull a complete data pull from the system after updating existing hardware which prevented OSA staff from being able to complete an annual valuation based on current data. While this was not the most ideal practice it will still present the needed materials for the valuation as well as a model for what the annual valuation will look like in coming years as we transition from a full annual report to receiving the complete valuation on a biennial schedule.
