October 28, 2022

The 237th regular meeting of the Board for Volunteer Firefighters and Reserve Officers was convened at 9:00 A.M. in the Redwood Board Room of the Spokane Davenport Grand Hotel by Chair Martin Spani, with Board, Board Member Debora Smith, Board Member Brian VanCamp, Board Member Phin Haglin, and Executive Secretary Hailey Blankenship present. Also present via zoom were Michael Harbour, Kevin Lee and Frank Serra of the Office of the State Actuary, Chris Phillips and James Aber of the Washington State Investment Board and Mary Ann Walker and Heath Simpson of Linea Solutions.

Secretary Blankenship requested the presentations by WSIB, OSA and Linea be moved to the top of the agenda.

The Board reviewed the July 25th Board Meeting Minutes. It was motioned by Board Member VanCamp, seconded by Board Member Smith and carried to approve the previous meeting minutes with no noted corrections.

FIRST HEARING OF THE PUBLIC

OLD BUSINESS

Secretary Blankenship updated the Board on the progress of the benefit enhancement project. Secretary Blankenship reminded the Board that the legislation was submitted the beginning of September for the upcoming 2023 legislative session. The Board was provided a second draft of the legislation in bill format from the Code Revisers office with no additional changes expected. The next steps are to retain a bill sponsor. Secretary Blankenship explained that due to the purpose of the proposed changes, it would be agency led legislation but she will be seeking the support offered by the Washington State Fire Commissioners, Fire Chiefs, Firefighters Association and Sheriffs and Police Chiefs to provide the best opportunity of a successful outcome. Assuming the bill passes, documentation will be resubmitted to the IRS for review.

Secretary Blankenship updated the Board on the database replacement project, introducing Pension Technology Group (PTG) that was secured through a competitive procurement as the solution vendor. Linea Solutions Inc. project manager Mary Ann Walker and business analyst Heath Simpson joined the conversation and presented the Board with a handful of slides outlining the current phase of the project, cost and key dates to look forward to. Both Mary Ann and Heath provided a positive outlook on where the project is at to date and expect a successful outcome. Currently the vendor is learning the current business processes so they can outline how the pension pro plus product will be modified to fit BVFF needs. It is anticipated that training sessions will starts in the summer of 2023, available in person over web video tutorials and hopefully at upcoming conferences.

Secretary Blankenship updated the board on the LODD Benefit under review for Alan Basso. Following a review of the IME results that were received in July, Mrs. Basso indicated she wished to pursue the Appeals process for the decision to deny LODD benefits. Currently, there are additional records being subpoenaed, once received and all parties have been able to review a hearing date will be set.

NEW BUSINESS

Chris Phillips from the Office of the State Actuary addressed the Board for the 2021 performance update. He started the presentation by introducing his successor, James Aber. Chris will be retiring from state service and over a span of time has been preparing the hand the reins to James. The data presented to the Board will be the first performance update since the restructuring. Results are based on data from the end of the third quarter (September 2022). Fund balance is sitting at one hundred ninety eight million, even with the restructuring of investment plan the liabilities still remain funded. WSIB will continue to follow appropriate practice in a volatile market and not overreact in an uncertain market. A rick tolerance will be maintained for long term picture.

Frank Serra and Michael Harbour from the State Actuaries Office presented to the Board valuation report. This years' valuation is the first to be presented in the trial format in which data is rolled over from the previous year. A standard valuation will completed in odd years while a modified version will be presented in even years. This new format speeds up production time and allows for additional projects to be completed on behalf of BVFF. OSA staff also noted a plan to revisit the plans administrative factors that are used to determine pension amounts calculated with age reductions, lump-sums and survivor benefits. They will also be assessing the upcoming changes from the 2023 legislative session. This years' valuation also relied on the 2022 VFF Economic Experience Study. There was increase in the funded ratio from 104% to 106% as market assets as well as actuarial value of assets continued to increase. Given the data approach used in this years' valuation contribution rates were not updated; however, the reasonableness of the 2020 VAVR calculated rates were taken into consideration and note they continue to be reasonable looking into the 2023 calendar year.

The Board discussed and set the annuals fee for Reserve Law Enforcement and EMSD's, Board member Haglin moved and Board Member VanCamp seconded, to set the fees at \$135 for pension enrollment and \$235 for relief benefits. These are the same as they were in 2022.

The Board discussed and voted to not implement a surcharge for 2023 and continue to evaluate on an annual basis (Haglin moved, Smith seconded). The Board requested that Secretary Blankenship work on developing a criteria for implementing a surcharge on a case by case basis and relative surcharge amounts.
