The 243rd regular meeting of the Board for Volunteer Firefighters and Reserve Officers was convened at 9:00 A.M. in Suite 206 of the James R. Larson Forum Building by Chair Martin Spani, with Board Member Debora Smith, Board Member Brian VanCamp, Board Member Miland Walling and Executive Secretary Hailey Blankenship, Board Member Haglin joined via Teams. Also present via Teams, Kevin Lee and Frank Serra of the Office of the State Actuary and Saurahb Maheshwari of Linea Solutions.

There were no corrections to the agenda.

The Board reviewed the January 22, 2024 Board Meeting Minutes. It was moved by Board Member VanCamp, seconded by Board Member Walling and carried to approve the previous meeting minutes with no noted corrections.

FIRST HEARING OF THE PUBLIC

OLD BUSINESS

Secretary Blankenship provided an update on the database project. While early delays and development changes pushed the implementation back to a three phased approach beginning in May of 2024, user acceptance testing is nearing completion for the first go-live. Line of business, which completely replaces the Access Database for key business processes will go-live in May. The municipality portal will be implemented in July of 2024 followed by the Payroll piece in November of 2024. Currently, BVFF staff are continuing data clean up and are nearing completion of testing and preparation for data cutover. In addition to BVFF staff, Linea has three individuals assisting with product testing. Secretary Blankenship provided a system overview and the Project Manager of Linea Solutions, Saurahb provided and brief overview of the project status and review of the quality assurance report provided by Vivid Co.

With great excitement Secretary Blankenship shared with the Board the IRS private letter ruling was received back with a favorable outcome and the benefit increase and removal of the cap of twenty five payments went into effect on February 1, 2024. BVFF Staff are working through the manual recalculation of all monthly benefits. It is taking a bit of time as each benefit has to be manually recalculated then manually entered into the payroll system then verified and a letter sent. All benefit increases will be back dated to the February 1st effective date. The annual fees will be increased January 1, 2025 to allow for municipalities to accommodate the increase to their budgets.

Secretary Blankenship reviewed two budget items with the Board that were not requested but included in the agencies budget. The first item was for ninety-one (91) thousand proviso to be used for small agency finance services. This service was proposed and included under a recommendation from OFM, Secretary Blankenship explained that this was not a desired request or inclusion as the cost break down balance from an agency perspective. Services in Accounts Payable, Accounts Receivable and Budget; Secretary Blankenship is still

trying to determine if it is a required spend. The second item was a fifty (50) thousand proviso to complete a study on presumptive disease data. This project was proposed by the Washington State Firefighters Association and Secretary Blankenship was supportive of and included in those conversations; however, the proposal as included in the budget bill was misinterpreted and should have been put in the Department of Commerce's budget rather than BVFF. Board Member VanCamp moved to not spend the funds under the proviso amount and have the WSFFA resubmit next budget cycle for the project to be proposed and budgeted correctly. Board Member Haglin seconded and it was carried unanimously. Secretary Blankenship will work with the appropriate parties to address this.

NEW BUSINESS

The Board was presented with a Permanent Partial Disability Award for Donald Taylor. Mr. Taylor had a lower back injury on August 1, 2013. For many months he managed the pain with anti-inflammatories then had an evaluation and diagnosis of an extruded disk fragment. In 2019 he decided to have surgery. He quit firefighting at the time of this surgery. While the surgery corrected the back pain the continued and unimproved foot drop are still present. Mr. Taylor does wear a device to aid in symptom reduction but it is not expected that surgery or on-going treatment would correct further. Based on the independent medical examination he was provided a WAC 296-20-280 Category 4 impairment to the right leg. This rating provides a 15% impairment and lump sum payment of \$29,166.99. Board Member Haglin moved and Board Member Walling seconded and it was carried to approve the PPD.

The Board reviewed the Secretary's leave and pay records

The Board reviewed and approved (Smith moved, VanCamp seconded) the administrative expenditure vouchers numbered #03089 through #03178 and various travel vouchers.
